- **ENROLLMENT FEE:** \$50.00 DUE AT TIME OF ENROLLMENT (FIRST TIME MEMBERS ONLY)
- **SS ESCROW FEE:** \$350.00 DUE AT TIME OF ENROLLMENT [FOR EACH SIX (6) MONTH PERIOD]

ENROLLMENT REQUIREMENTS

- PKC Permanent Registration
- Complete DNA Profile - Stud Dog must be submitted for DNA Profile to allow pups sired by him to be correctly matched with him before being certified eligible to compete for the Super Stakes Championship(s). DNA profile fee of \$40 and DNA sample must be included with the application for members entering the program for the first time.
- Dog cannot be taken out of 2006 Super Stakes Program unless he dies (registration papers must be returned to the PKC office) or becomes sterile (veterinarian statement required).
- If dog should be sold during 2006 Super Stakes Year, the member enrolling the dog **REMAINS RESPONSIBLE** for payment unless the new owner assumes liability via written documentation from the new owner. Form provided by PKC on request.
- **Any unpaid fees from previous years enrollment must be satisfied before enrollment in the current year's program is accepted.**
- Upon certification and qualification by Pup's Owner, each pup sired by the above sire will be eligible to compete in the Super Stakes Junior Championship in 2007 and the Super Stakes Championship in 2008.
